**133527 MINUTES OF PREVIOUS MEETING:** To confirm as a correct record the minutes of the meeting held on the 8<sup>th</sup> February 2022 and authorise the Chairman to sign.

**Resolved** – the minutes from the meeting held on the 8<sup>th</sup> February were confirmed as a correct record and the Chair was authorised to sign

**133528 CHAIRMAN'S COMMUNICATIONS:** To receive such communications as the Chairman may wish to lay before the committee. None received.

**133529 ALLOTMENT INCOME AND EXPENDITURE**: Committee to receive and note the Income and Expenditure to 31<sup>st</sup> January 2022 (Potter/Sutton)

**Resolved** - the Income and Expenditure to 31<sup>st</sup> January 2022 was noted

**133530 TRANBY LODGE GARDENS OPEN SPACE** – Committee to consider the transfer of the land to Hessle Town Council from Persimmon Homes Yorkshire, in order that it can be retained as open space for the enjoyment of the wider community. As per letter and plan, and email from Cllr Nolan.

Cllr Potter welcomed the residents to the meeting and their comments on the proposal.

The residents in attendance were most upset by the situation and did not want the land to become an open space for the public. Prior to it being bought back by Persimmon it was owned and maintained by one of the residents and they saw no need for this to change. They are concerned that it would become an area for ASB, litter and dog mess, and may have a detrimental effect on their homes.

Cllr Nolan explained that currently the area lacks biodiversity, and by the Town Council taking the land over it would create a green corridor to the woods in the North. The involvement of the Friends of Tranby Gate in helping to look after this area would make it into a nature area, and possibly increase the trees and foliage to attract wildlife, the friends are more than willing to work with the residents in creating a natural space for all Hessle residents to enjoy. The wood to the North would be maintained by Persimmon.

Concern was raised that trees were currently being removed, Cllr Sutton advised that the tree committee had visited the site and were not opposed to the removal of 12 trees, which were small bushes only not well established. Assurances had been given by Persimmon that re-planting will take place by once the development works had been completed. This will be monitored by ERYC.

The residents left the meeting, and the committee discussed the item. Following a vote - 6 for, 1 against it was resolved to pass over to Full Council for further consideration.

**Resolved** – That the decision to take ownership of the amenity land on Tranby Lodge Garden from Persimmon Homes be passed to Full Council for further discussion and that a decision be made.

**133533 MEMORIAL BENCH REQUEST** – Committee to consider the request from Cllr Nolan to fund the purchase and installation of a Memorial Bench, in memory of former Cllr Frank Kitchen. A discussion took place, and it was agreed to fund a bench in memory of the late Frank Kitchen. A suggested location being where The Haven meets the Humber on Jean's Walk. Suitable locations to be discussed with the family and then to submit to ERYC. (Nolan/Sutton)

**Resolved** – to fund the purchase and installation of a Bench in memory of Frank Kitchen, to discuss a suitable location with his family and then submit an application to ERYC.

Cllr Potter gave a presentation, suggesting a Boulevard delta 60 Trough, height of 60cm, Length of 80am and Depth of 55cm. A discussion was held on suitable areas and as to whether permission would need to be sought from ERYC. The clerk will also investigate the regeneration / High Street fund and see any funding can be obtained through that.

**Resolved** – agree to the purchase of 10 Boulevard delta 60 Trough planters - height 60cm. for the following locations – south corner of the Square opposite the cake room, The east corner of the Square near the tree, near to co-op ,traffic island opposite Turner and Sellers, north side of the Square opposite the Co-op near the crossing. To also install 2 x half barrels on the amenity land on Southgate opposite All Saints Church Hall. The clerk will contact ERYC for permission to instal the planters.

**133538 EAST RIDING OF YORKSHIRE COMMUNITY TREE PLANTING FUND – 2021** – Committee to note that all trees have been planted and the grant funding received. Noted.

**133539 TOWER HILL MEMORIAL PARK** – Clerk to provide any further update.

The Clerk advised that the park will be passed over to Hessle Town Council on the 1<sup>st</sup> April 2022, and the grounds maintenance company have been instructed to start grass cutting from April. The council is working alongside ERYC in obtaining quotes for the play area refurbishment. It is hoped they will be received prior to taking the park over.
