# 134435 HESSLE TOWN COUNCIL BUDGET 2024/25 & PRECEPT FIGURE 2024/25:

To consider the budget heading figures and to arrive at the \*precept figure for 2024/25.

All figures to go to Full Council on 23<sup>rd</sup> January 2024 for approval.

An updated forecasted financial report was given to members at this meeting.

\*The Local Precept Demand from ERYC is required by return on Friday 19<sup>th</sup> January 2024 and the Clerk has informed East Riding Council that this will be done after Hessle Town Councils Full Council meeting on 23<sup>rd</sup> January 2024.

A copy of the letter received from ERYC with their final recommended and approved 2024/25 Council Tax Base figure for Hessle was attached.

ERYC require a detailed breakdown of the precept figure to be displayed on the ERYC website (and ours) for information, and giving reasons for any changes. This only applies if the precept figure arrived at is £140,000.00 or above.

As in previous years ClIr Davison is invited or may kindly offer to prepare the above with the Clerk.

**RESOLVED and RECOMMEND** to Full Council that with taking on additional services and increasing expenditure costs, that have been covered for a number of years with reserves which is unsustainable, and following proposals for additional budget funding received at this meeting from Councillor Nolan and Councillor Pickering to add £2,500.00 to the Events Budget to cover Hessle Town Council organising road closures for a Remembrance Day Parade requested by the Hessle British Legion and which is required to cover the ERYC legal paperwork, Health & Safety and Risk Assessments, Traffic Management, Marshalling and First Aid requirements (Councillor Pickering confirmed that he would arrange a Working Group in order to undertake the paperwork and necessary requirements) and for an amount to be added to the Civic Budget for new Mayoral Chains to replace the (now full) existing ones, the Precept figure be set at £330,374.00 This equates to a £12.44 per annum increase for a Hessle Band D property from £48.66 to £61.10, which is an increase of 25.57% or £1.036p per month (2024/2025 Hessle Town Council Tax Base figure = 5406.7) and the shortfall of £44,500 is transferred from Reserves. This follows discussions and the line by line calculations carried out by the Chairman of the Finance Committee, the Clerk and all members of the Budget Committee at this meeting, together with discussions by members of all other Committees at previous meetings held on Budget Requirements for 2024/2025 and that this process has been conducted in accordance with the law, regulations and proper practices to ensure public money is safeguarded and accounted for.
